SECURE THE BORDER AND DEFEAT THE CARTELS

President Trump, Border Czar Tom Homan, and Department of Homeland Security (DHS) officials secured the border in record time, **resulting in a 95% decrease in border crossings — the lowest level in decades.** They achieved this by resuming construction of the border wall, ending “catch-and-release,” reinstating the highly successful Remain in Mexico policy, and reforming the asylum system.

- President Trump and Elon Musk launched the Department of Government Efficiency (DOGE), which has **saved taxpayers nearly \$160 billion** by identifying inefficiencies, reducing bureaucratic bloat, eliminating entire agencies, and canceling grants or contracts that serve no purpose.

It has also **secured over \$5 trillion in new investments** that will create 461,000 new jobs and set the stage for a new era of American prosperity. It [became](#) the **world’s largest net exporter of liquified natural gas**, signifying that America is open for business and is the premier supplier of global energy abundance via clean and reliable natural gas.

- Following the administration’s recommendation, numerous states are requesting waivers from the U.S. Department of Agriculture’s Food and Nutrition Service to **eliminate purchases of sugary beverages and junk food in SNAP**.

END GOVERNMENT WEAPONIZATION AND OVERREACH

- President Trump signed an executive order to **end the weaponization of the federal government** and has called for **reigning in rogue federal judges** who have undermined his lawful authority as president.

- President Trump signed an executive order temporarily **halting offshore wind leasing** and calling for the review of the federal government's leasing and permitting practices. Secretary of the Interior Doug Burgum then **halted**

construction of an offshore wind project that had been hastily approved by the Biden administration, highlighting the threat of government overreach.

DELIVER PEACE THROUGH STRENGTH

- The Trump Administration released its America First Investment Policy, emphasizing that "economic security is national security," and underscoring the importance of **restricting Chinese Communist Party (CCP)-affiliated individuals from investing in critical sectors** such as technology, healthcare, agriculture, energy, and raw materials. The policy also recognizes the Committee on Foreign Investment in the United States (CFIUS) as a primary enforcement tool.

These ideologies are equally hostile to Christianity and the West. If they succeed in driving Jewish life underground, they will target Christians next.”
